It includes three brand-new coolers, a modern steam oven, and a fully updated, professionally grounded electrical system. Both the Rational oven and grill are under five years old, as are the dishwasher and rinsing system, which receive preventive maintenance every six months.


Additional kitchen features include several freezers (single and double), an au bain-marie, smoothie machines, a dough mixer, a vacuum sealer, and a slicer – all the equipment needed to maintain high culinary standards. The kitchen is well-ventilated with five ceiling fans and air conditioning, and it also has a powerful extraction system that's less than six months old.

The cozy bar area is equipped with a wine cooler, beer fridge, post-mix system, doubledoor cooler, small refrigerator, and a high-end Lide coffee machine. Inside the restaurant, two air conditioners provide a pleasant indoor climate, even on the warmest evenings.

Guests instantly feel at home thanks to the inviting and atmospheric interior, enhanced by modern amenities like a Sonos sound system (tablet-controlled), two flatscreens, cable TV, HDMI connections, fiber-optic internet, and a security system with five strategically placed cameras – ideal for streaming events or sports. A modern POS system ensures easy and efficient transactions. Two sturdy security shutters offer peace of mind outside operating hours.
