Description

Interesting freehold lot with a building permit for 3 apartments. Construction drawings are included. The plot measures 6,975 sq.ft (648 m²), is elongated in shape, and fully fenced.

Layout

This lot is appr 138 feet (42 meters) deep and has a rectangular shape. The property is fully fenced and features a gate at the front.

It is located on a local access road.

According to the OLB, this road is scheduled to be paved with bricks in 2025. The lot offers easy access to the surrounding area.

The original lot 4-G-2886 measured 8,665 sq.ft (805 m²) and was officially subdivided in 2024. The current lot of 6,975 sq.ft (648 m²) has been assigned a new cadastral number: 4-G-4184.
